Entry & Payment Info: Entries are accepted now. *Entry fees include CFA/Regional surcharges.* No additional fees for online/faxed entries or substitutions. Per show rule 6.21, each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to New England Meow Outfit; US checks only. **Entries can be paid via PayPal PRIOR TO CLOSING; send to nemocatclub@gmail.com (do NOT use old "Yahoo" address) Entries paid at the door must be in cash and exact change!** It is the exhibitor's responsibility to confirm receipt of online/fax entries with the Entry Clerk; the club will not be responsible for entries lost due to communication errors. Check your confirmation for accuracy! Please contact the entry clerk with any corrections BEFORE CLOSING DATE. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench.

Show Hours: Check-In: 8-9 am. **Judging Hours:** 9:30 am-5 pm (or end of finals) on Saturday; 8:00 am- (YES, 8:00 am!)-4 pm (or end of finals) on Sunday.

Benching: Single cage size is approximately 22"x22"x22" and is included with your entry. Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage. Benching requests made at the time of entry will be honored when possible. Clay litter will be provided. Bring your own litter pans, cat food, and water/food dishes.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers but will not be scored for CFA

This show WILL BE advertising for spectators. All exhibitors will be expected to follow mandatory CFA COVID requirements and local, state, national and event facility regulations.
